

## PERFORMANCE DOG SALES AGREEMENT

This AGREEMENT is in regards to a WHIPPET male/canine.

This is an agreement between breeder; Jenette Mackey-Gersich, TreasureChest Sighthounds, Olympia, WA. and buyer;

This canine is being sold as a performance prospect. Companion dogs are sold on a spay/neuter contract, however, since you have agreed to campaign this puppy, this clause is changed with the following: The breeder feels for the overall longevity and health for the dog, it should be spayed or neutered by 10 years of age but will not require it. If the buyer provides proof of the surgery, the breeder will refund \$50 of the original purchase price. If the buyer decides to breed this dog, she will get the consent from the breeder first.

The breeder also adds to the performance dog agreement, if the puppy turns out to be non-performance quality due to lack of keenness, severe cramping or a structural defect provided in writing from a veterinarian, the breeder will replace the puppy. This does not apply to the actual speed/grade of the puppy only health & structural-related issues.

Breeder guarantees that puppy is in good health and has received appropriate medical inoculations and care and is free from parasites as of the time of sale. Breeder will provide Buyer with a medical history detailing treatment Puppy has received under Breeder's care. Breeder will have the puppy microchipped. This canine is guaranteed against any genetic defect. Should any genetic defect be pronounced by two qualified vets in writing to breeder, the original purchase price will be refunded. The original puppy does not have to be returned to breeder unless buyer so desires. However, if buyer does not wish to keep the original canine, it MUST be returned to breeder at buyer's expense before breeder refunds and money.

Buyer agrees to furnish breeder any change of address or telephone number should it change from that stated above, for the life of the puppy.

Buyer agrees that if at any time, for any reason, buyer does not want, or cannot keep said canine, canine MUST be returned to the breeder. There are no exceptions to this. If breeder is dead/unable physically to take dog, Buyer must return dog to the nearest AWC rescue.

**If canine is found to have been sold or given away without Breeder approval or kept inhumanely, Breeder has the right to remove canine without permission and may take legal action to recover the same and original Buyer will be responsible for all expenses.**

Buyer agrees that this canine will be a house dog, will not be chained outside, will not live outside, will be maintained in a fenced yard, will not be allowed to run loose, that all vaccinations will be administered on the proper schedule as determined by your veterinarian, and that this canine will be maintained in healthy, sanitary and comfortable conditions.

If a situation arises where a veterinarian recommends that this canine be put to sleep for any reason, breeder will be first notified and reserves the right to obtain a second opinion at breeder/sellers expense. If a second opinion does not confirm the first opinion, the breeder reserves the right to take back said canine without a replacement if it is determined that no genetic defect is apparent.

This agreement is in accordance with the laws of the State of Washington. Upon signing this agreement, both parties agree that they have read and fully understand this agreement.
